

TERMS OF SERVICE AGREEMENT

ACCEPTANCE OF TERMS

DESCRIPTION OF WEBSITE SERVICES OFFERED

The Site is an e-commerce website which has the following description:

The user and/or member acknowledges and agrees that the Services provided and made available through our website and applications, which may include some mobile applications and that those applications may be made available on various social media networking sites and numerous other platforms and downloadable programs, are the sole property of Sherline Products Inc. At its discretion, Sherline Products Inc may offer additional website Services and/or products, or update, modify or revise any current content and Services, and this Agreement shall apply to any and all additional Services and/or products and any and all updated, modified or revised Services unless otherwise stipulated. Sherline Products Inc does hereby reserve the right to cancel and cease offering any of the aforementioned Services and/or products. You, as the end user and/or member, acknowledge, accept and agree that Sherline Products Inc shall not be held liable for any such updates, modifications, revisions, suspensions or discontinuance of any of our Services and/or products. Orders are shipped Monday – Friday. Expedited orders must be placed by 9 am PST to ship the same day.

Orders shipping ground have a processing time of 7 working days for domestic orders and 14 working days for international orders.

Orders shipping to the US ship with USPS and UPS. We can also ship via FedEx at your request.

Small orders going to Canada will almost always be sent by USPS to help save on shipping and import costs. Orders going to APO/FPO boxes will also be sent via USPS.

We do not drop ship to the US for international customers. This includes using forwarding companies. Your order will be cancelled without notice.

Shipping charges and available service will vary based on package weight and country of destination. If you want us to determine the best shipping method you can select that option at checkout.

We do not charge a flat rate for shipping because of the variations in weight for our products. Instead we charge you what the shipping company charges us. Our website uses a shipping calculator based on the daily rates for USPS and UPS based on the weight and destination of the shipment. You can also have us use your UPS/FedEx account number to charge your shipping to. Just enter it in the appropriate box on the checkout page.

ORDER TRACKING

You will receive an automated email from the shipping company with your tracking information once the order ships. If you have registered an account with us you can also find the tracking number for any order by logging into your account and viewing your order history.

STOCK & BACKORDERS

All items are normally in stock, however backorders do occur. If your order contains multiple items and one of them is on back order we will charge you for the entire order and then ship the backordered part once it's in stock at no additional charge.

CHANGING/CANCELLING ORDERS

If you wish to cancel or change your order for any reason, please contact us as soon as possible. If you have an account on our website you can view your orders in your order history and cancel them there.
